Statement of Program Service Accomplishments

Pachamama Alliance partners with Indigenous peoples of the Amazon rainforest to protect their ancestral lands and cultures and engages individuals worldwide in education and action to build a just, sustainable, and thriving world. Our work integrates environmental conservation, Indigenous rights advocacy, sustainable economic development, and transformational educational programs.

Amazon Rainforest Protection and Indigenous Partnerships:

As a fiscal sponsor and strategic partner, Pachamama Alliance supports Fundación Pachamama and other Indigenous-led organizations in Ecuador and Peru working to protect the Amazon rainforest and promote Indigenous rights. In 2024, these efforts contributed to the protection of approximately 9.8 million acres of ancestral lands, expanded conservation agreements with Indigenous communities, and supported reforestation projects that planted over 173,000 trees across more than 2,600 acres of degraded land.

Through our fiscal sponsorship and partnerships, we supported Indigenous-led economic initiatives, including 54 bioenterprises that generate sustainable livelihoods, and helped advance climate finance solutions like biocultural credits, which raised over \$43,500 to support Indigenous conservation. Health initiatives such as Ikiama Nukuri trained Indigenous women as health promoters, distributed nearly 500 safe birth kits, and improved maternal and infant healthcare access in remote communities.

Human Rights and Legal Advocacy:

We supported Indigenous partners in their efforts to secure legal protections for the rights of people and nature. In 2024, this included supporting legal advocacy for Indigenous consultation rights, providing scholarships for environmental law education, and backing Indigenous leadership development in climate justice and biodiversity protection.

Ecotourism and Sustainable Development:

Pachamama Alliance provided support for Indigenous-owned ecotourism projects, such as Kapawi Ec lodge and the Naku Center, which promote environmental conservation, cultural preservation, and local economic resilience.

Global Education and Leadership Programs:

In addition to our work supporting the Amazon, Pachamama Alliance offers transformational educational programs for individuals and communities worldwide. These programs cultivate ecological awareness, social justice leadership, and global citizenship:

- Awakening the Dreamer: A 90-minute introduction to global challenges and the role of individuals in building a sustainable future, with 1,408 participants in 2024.

- Game Changer Intensive: An eight-week course supporting participants in taking leadership for justice and sustainability. In 2024, 1,718 people participated.

- Climate Action Training: A 10-week leadership program for community-led climate solutions, and a one-hour Climate Action Now course. Together they reached over 580 participants in 2024.

- Earth Listening Circles: A new initiative bringing people together to build reciprocal relationships with the Earth, with over 600 participants in 2024.

- Resilience and Possibility Webinars: A series featuring global thought leaders, engaging over 1,100 people in dialogue on systems change and environmental justice.

In total, these programs reached participants from 104 countries, helping individuals reexamine their relationship with the Earth and take action for social and ecological transformation.

Collaboration in the Sacred Headwaters:

Pachamama Alliance supports the Amazon Sacred Headwaters Alliance (ASHA), a coalition of over 30 Indigenous nations across Ecuador and Peru working to permanently protect 86 million acres of rainforest. In 2024, ASHA advanced its Bioregional Plan 2030 and achieved international recognition, including being named an Earthshot Prize finalist.
